





- Avoid costly/non-value added translation activities
- Enable fast and widespread connectivity
- Avoid "one-off" custom connections

Total Inventory: 611,872


Total Consumption: 73,357



- Supply Chain Collaboration

- Engage potential Solutions Providers




Implementation Status

papiNet Transportation

- Engage the CIDX standards group in the enhancement of their transport and logistics messages to incorporate paper and forest products industry requirements.
- Signed collaborative agreement completed early 2003
- Initial pilot of one message Shipment Status for Q2 2003
- Explore the opportunities to participate with CIDX Convergence and Partnering group in monitoring the XML global cross industry standards landscape
- January 2003 Launch in Vienna (EU)
- March 2003 Launch in New York (NA)
- April 2003 Workshop in Hamburg
- May 2003 Engage CIDX Change Control Process
